**GUIDELINES FOR ORIGINAL CERTIFICATE VERIFICATION**

**Ensuring Eligibility of Candidates Admitted by Management under Management Quota/Spot Admissions/SW-II (Minority Category) for the Academic Year 2025–26**

The Principals/Directors of affiliated colleges and affiliated autonomous colleges of JNTUH, offering **M.Pharmacy/Pharma.D(PB)** programs are hereby informed to get **Original Certificate Verification** to confirm their eligibility for admissions made under Management / Spot categories for the academic year **2025–26**.

***Note:** Original certificate verification is not required for candidates admitted through online Convener admissions, as the verification process is already completed at Helpline Centers under the supervision of the competent authority.*

Further, the list of admitted candidates must be submitted **through online mode only** at <https://doaratifications.jntuh.ac.in>. Payment of **Ratification Fee** shall also be made **online only**, and the fee receipt should be submitted at the time of Original Certificate Verification as per the slot booked by the concerned Principal.

## A). Documents to be Submitted by the Principal

### (i) Candidates admitted by the Convener (SW-I): (Upload through online mode only)

- Provisional Approval/Ratification copy of Telangana Council of Higher Education (TGCHE).
- List of admitted candidates through Convener Admissions (Branch-wise).  
(Note: In case of cancellations in the TGCHE approved list, the list should be manually updated and attested by the Principal before uploading.)
- Ratification Fee: Rs.1200/- per branch.

### (ii) Candidates admitted under Category-B (Management Quota)/Spot Admissions: (Upload through online mode only)

- Provisional Approval/Ratification copy of TGCHE.
- List of admitted candidates through Management (Category-B) and Spot Admissions (Branch-wise) using login credentials shared with the Principal's registered email ID.
- Ratification Fee: Rs.600/- per admitted candidate.

### (iii) Candidates admitted by the Convener (SW-II): (Upload through online mode only)

- Provisional Approval/Ratification copy of Convener SW-II, TGCHE.
- List of admitted candidates through Convener SW-II Admissions (Branch-wise).
- Ratification Fee: Rs.600/- per admitted candidate.

## C). Important Notes

1. If the Principals/Directors of affiliated colleges fail to submit the admitted candidates' lists and Ratification Fee within the prescribed schedule, a **penalty of Rs.1500/- per candidate** shall be levied, payable on or before **11.03.2026**.
2. If no admissions are made under Category-B/Management Quota/Spot in a particular specialization, the Principal must submit a **"Nil Report"** for that specialization.
